

“Prize Ride 1” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Prize Ride 1 Sweepstakes" ("Sweepstakes") will begin at 08:00 a.m. GMT on September 19th and end at 08:00 a.m. GMT on September, 26th, 2013 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

To enter the Sweepstakes, guess which car is displayed on the picture. Comment under the post to receive one entry into the Sweepstakes. Each entrant may submit only one entry during the Sweepstakes Period. Any attempt by any person to enter more than one entry by using multiple/different email addresses, identities, registrations, or any other methods will void all entries entered by that person and that person, at the sole discretion of Sponsor, may be disqualified from the Sweepstakes.
