

“Brothers in Arms 3” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Brothers in Arms 3 Sweepstakes" ("Sweepstakes") will begin at 2:00 a.m. GMT on April 3rd, 2015 and end at 4:00 a.m. GMT on April 7th 2015 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

Eligibility: Sweepstakes is open to individuals (excluding residents of the province of Quebec in Canada, Cuba, Iran, Syria, North Korea, Brazil, Italy, Myanmar (formerly Burma) and Sudan and any other jurisdiction where the Contest would be prohibited by law) who are at least eighteen (18) years old at the time of entry, who have an existing Internet connection and who did not purchase any products, services or equipment for the purposes of entering this Sweepstakes. Employees of Sponsor and any of their respective parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members (any person living in the same household of any of the foregoing for at least four (4) of the twelve (12) months preceding the start of the Sweepstakes) of each such employee and any other entity engaged in any way in the development, production, printing, distribution or execution of this Sweepstakes (collectively, the "Sweepstakes Entities") are not eligible. If it is found that a person who does not meet the eligibility criteria set forth in these rules has submitted an entry, that entry will be deemed ineligible and any prize awarded shall be revoked. All federal, state and local laws and regulations apply. Void where prohibited.

To Enter: During the Sweepstakes Period, visit Brothers in Arms 3's Facebook page at <https://www.facebook.com/BIAgame>. If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free. Once you're a fan, you can go on the Sweepstakes post on Brothers in Arms 3's page. To enter the Sweepstakes, you must post a screenshot containing the game character shooting at an Easter egg which should explode into confetti. In order for an entry to be valid the photo must contain both the Easter egg and the confetti.

Each entrant may submit only one entry during the Sweepstakes Period. Any attempt by any person to enter more than one entry by using multiple/different email addresses, identities, registrations, or any other methods will void all entries entered by that person and that person, at the sole discretion of Sponsor, may be disqualified from the Sweepstakes. Use of any automated system or similar devices to participate is prohibited and will result in disqualification.

Sweepstakes Entities are not responsible for Internet malfunctions, failures or difficulties of any kind, or for illegible, damaged, lost, late, misdirected, incomplete or postage due mail or entries. Incomplete entries, or those containing incorrect information, will be voided. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sweepstakes Entities reserve the right to disqualify any person or address suspected of submitting fraudulent entries or of tampering with the entry process. All entries become the property of the Sweepstakes Entities and will not be returned.

Agreement to Official Rules: Entry and participation in this Sweepstakes constitutes participant's full and unconditional agreement (and permission of an entrant under the age of majority in his/her state or country of residence (a "Minor") to enter and participate in this Sweepstakes constitutes such Minor's parent/legal guardian's full and unconditional agreement on behalf of themselves and the Minor participant) to abide by these Official Rules (exact compliance is essential) and accept the decisions of Sponsor and its agents as final and binding in all matters related to this Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

Drawing and Notification:

The number of prizes will be dependent on the number of comments the Sweepstake gathers. Some prizes will be awarded to all eligible participants and will differ on the number of comments the Sweepstake post gathers:

- Over 2000 comments --> VIP status for 2 days for each valid participant
- Over 4000 comments --> Pyro Bundle for each valid participant
- Over 6000 comments --> 200 medals for each valid participant

The prizes are not cumulative. If 4000 comments are gathered, valid participants will not be receive the VIP status; they will receive only the Pyro Bundle.

There will also be prizes that will be awarded only to a few participants selected through random.org.

- 10 MP40 Weapons will be awarded to 10 people selected using random.org from all eligible participants. These 10 weapons will be awarded for sure, no matter how many comments the post receives.
- If the number of post comments goes over 8000, we will increase the number of MP40 weapons to 20.

The Drawing of the winners will take place until April 10th and the prizes will be awarded until April 17th.

In order to receive the prizes, all participants must be logged-in with Facebook in the game.

An entry will be deemed to be received on the date an entrant posts a comment with the correct answer. The odds of winning will depend on the total number of successful entries received. Winners will be notified by telephone, email and/or mail or directly in-game.

The prizes are eligible only on the iOS and Android platforms.

Prizes: The value of the prizes awarded randomly is of \$180 for 10 MP40 Weapons and of \$360 for 20 MP40 Weapons.

The value of the other prizes awarded to all participants will vary according to the number of participants but the value per each prize is:

- VIP 2 days: \$0.85
- Pyro Bundle: \$1.69
- 200 medals: \$5.64

Prize Conditions: Winners are solely responsible for all applicable federal, state, and local taxes associated with the receipt of any prize. **The prize winner address cannot be a P.O. Box.** If a prize is won by a minor, it will be awarded to a parent or legal guardian who must sign and return all required documents.
