

## **“Biography Contest” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Biography contest Sweepstakes" ("Sweepstakes") will begin at 04:00 a.m. GMT on 11, 16 and end at 12:00 p.m. GMT on 11, 18, 2016 ("Sweepstakes Period").
