

“Dungeon Hunter Update Gems Giveaway” Sweepstakes Official Rules

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Dungeon Hunter Update Gems Giveaway" ("Sweepstakes") will begin at 09:00AM EST on December 8th and end at 09:00AM EST. on December 10th, 2014 ("Sweepstakes Period").
