

## **“Dungeon Hunter Gem Giveaway” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Dungeon Hunter Gem Giveaway" ("Sweepstakes") will begin at 9:00 a.m. EST on June, 20 and end at 9:00 a.m. EST on June, 23, 2014 ("Sweepstakes Period"). To enter the Sweepstakes, answer the question by commenting. Click the submit button to receive one entry into the Sweepstakes. Each entrant may submit only one entry during the Sweepstakes Period.
