

Despicable Me: Minion Rush

“Minion Fever” Contest Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

INTERNET ACCESS, VALID E-MAIL AND FACEBOOK ACCOUNT NECESSARY TO PARTICIPATE.

VOID WHERE PROHIBITED BY LAW. ALL FEDERAL, STATE, PROVINCIAL AND LOCAL LAWS AND REGULATIONS APPLY.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules.

Gameloft's "Minion Fever" ("Contest") will begin at 02:00 p.m. GMT on April, 25, 2017 and end at 02:00 p.m. GMT on May, 16, 2017 ("Contest Period"). Contest is sponsored by Gameloft Inc. ("Sponsor").

If you are between the age of 13 and 18, please obtain your parents' permission prior to entering to the Contest.

Eligibility: Contest is open to individuals (excluding residents of the province of Quebec in Canada, Cuba, Iran, Syria, North Korea, Italy, Brazil, Myanmar (formerly Burma) and Sudan and any other jurisdiction where the Contest would be prohibited by law) who are at least thirteen (13) years old at the time of entry, who have an existing Internet connection and who did not purchase any products, services or equipment for the purposes of entering this Contest. 1/ Take a screen shot of your Minion running when Fever Mode is activated during the “Bubble Gum Invasion Episode 1: Back to the 80’s” Special Mission in the secret area of Gru’s Laboratory.

2/ Upload and post the screen shot on the Facebook Contest Post with the Hash Tag “#MinionFever.”

You must complete both steps to successfully submit your screenshot (your “Submission”). Only successful Submissions will constitute valid entries. Only valid entries will be eligible to win a Prize, as more particularly described below.

If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free.

By uploading your Submission, you represent and warrant that your Submission conforms to the Submission Guidelines and Content Restrictions (collectively, the “Submission Requirements”) set forth below and that Sponsor, in its sole discretion, may remove your Submission and disqualify you from the Contest if it believes that your Submission fails to conform to the Submission Requirements.

If there are an insufficient number of entries, Sponsor reserves the right not to award all the prizes. Judges' decisions in all matters relating to this Contest are final.

- Five (5) Prize Winners will receive Six Thousand Tokens (6,000) each, to be used in Despicable Me: Minion Rush (Approximate Retail Value of US \$60).
