

## **“Beauty and The Beast” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

- 11) Entrants who have registered for the Sweepstakes can obtain ten (10) additional entries by downloading the game Disney Magic Kingdoms on the Apple App or Google Play by clicking the button “Download Disney Magic Kingdoms” located at <http://www.disney-magic-kingdoms.com> Downloading the game is free. This game contains in-application purchases.
- 12) Entrants who have registered for the Sweepstakes can further obtain two (2) additional entries by clicking the button «Refer Friends For Extra Entries» located at <http://www.disney-magic-kingdoms.com>. The maximum number of friends you can refer is ten (10), thus the maximum number of additional entries you can receive is twenty (20).
