

## **“Zero” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Zero Sweepstakes" ("Sweepstakes") will begin at 15:00 P.M. - Ninety (90) Grand Prize Winners will receive Zero which Average Retail Value (ARV) is Nine US Dollars (US\$9). Grand Prize ARV is Eight-hundred and Six US Dollars (US\$806).
