

“Dragon Mania Legends Instagram Launch” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Dragon Mania Legends Instagram Launch Sweepstakes" ("Sweepstakes") will begin at 08:30 a.m. PST on December 1st, 2015 and end at 08:30 a.m. PST on December 4th, 2015 ("Sweepstakes Period"). To enter the Sweepstakes you have to post an in-game screenshot on your Instagram account of your favourite Dragon from Dragon Mania Legends and add the #MyDragonMania hashtag in the description of your post (the "Submission").
