

## **Despicable Me: Minion Rush**

### **“Banana Haunt Broadcasting Contest” Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

**INTERNET ACCESS, VALID E-MAIL AND FACEBOOK ACCOUNT NECESSARY TO PARTICIPATE.**

**VOID WHERE PROHIBITED BY LAW. ALL FEDERAL, STATE, PROVINCIAL AND LOCAL LAWS AND REGULATIONS APPLY.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules.

Gameloft's "Banana Haunt" ("Contest") will begin at 04:00 p.m. GMT on October, 28, 2016 and end at 04:00 p.m. GMT on November 11, 2016 ("Contest Period"). Contest is sponsored by Gameloft Inc. ("Sponsor").

**Eligibility:** Contest is open to individuals (excluding residents of the province of Quebec in Canada, Cuba, Iran, Syria, North Korea, Italy, Brazil, Myanmar (formerly Burma) and Sudan and any other jurisdiction where the Contest would be prohibited by law) who are at least eighteen (18) years old or who are over the legal age of majority in the country of residence where required by law if higher at the time of entry, who have an existing Internet connection and who did not purchase any products, services or equipment for the purposes of entering this Contest. If it is found that a person who does not meet the eligibility criteria set forth in these rules has submitted an entry, that entry will be deemed ineligible and any prize awarded shall be revoked. #### **To Enter:**

Download the "Despicable Me: Minion Rush" mobile game application, available from Gameloft for the Android and iOS platforms (the "Application") on the Google Play application store or the Apple application store. The Application is free.

During the Contest Period, you must:

1/ Livestream on Mobcrush (<https://www.mobcrush.com/>) your run in Level 45 of the Application and collect less than ten (10) bananas in one minute (00:00:60) (your "Video").

On iOS platform, use ReplayKit to livestream your run on Mobcrush (follow this tutorial to learn how to record your run with ReplayKit: [http://gmlft.co/DM2\\_RKBroadcasting](http://gmlft.co/DM2_RKBroadcasting)).

On Android platform, livestream your run directly through Mobcrush.

2/When livestream ends, post your Video on the Despicable Me: Minion Rush Facebook page at <http://gmlft.co/BananaHaunt> and comment on the “BananaHaunt” post. The comment section of the “BananaHaunt” post will appear on October, 28, 2016 on the Despicable Me: Minion Rush Facebook page. Upload your Video link using the hashtag “#BananaHaunt” in the Video title.

You must complete all two steps to successfully submit your Video (your “Submission”). Participants with a valid Submission that have collected less than ten (10) bananas in one minute (00:00:60) in Level 45 of the Application will be eligible to win the Grand Prize, as more particularly described in Prizes section below (the “Eligible Grand Prize Entrants”).

Participants with a valid Submission that have collected more than ten (10) bananas in one minute (00:00:60) in Level 45 of the Application will be eligible to win the Consolation Prize, as more particularly described in Prizes section below (the “Eligible Consolation Prize Entrants”).

If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free.

By using Mobcrush, you agree to all of the terms and conditions contained in Mobcrush Terms of Service (<https://www.mobcrush.com/pages/tos/>). In no way the Sponsor is responsible for the actions of Mobcrush.

#### **Content Restrictions:**

- The Submission must be your original creation and not subject to any third party interests (other than Sponsor’s);
- The Submission cannot have been previously submitted in a promotion of any kind or exhibited or displayed publicly through any means;
- The Video must not be edited with any video editing program;
- Submissions to the Banana Haunt Contest that Sponsor feels, for any reason, do not qualify under these Official Rules will be disqualified from the competition.

**Entering the Contest does not create or confer any license, right or ownership interest under any copyright, trademark or other intellectual property laws in or to any intellectual property owned and/or controlled by the Universal Parties.**

Each participant may submit only one entry during the Contest Period. Any attempt by any person to enter more than one entry by using multiple/different email addresses, identities, registrations, or any other methods will void all entries entered by that person and that person, at the sole discretion of Sponsor, may be disqualified from the Contest. Use of any automated system or similar devices to participate is prohibited and will result in disqualification.

Sponsor is not responsible for Internet malfunctions, failures or difficulties of any kind, or for illegible, damaged, lost, late, misdirected, incomplete or postage due mail or entries. Incomplete entries, or those containing incorrect information, will be voided. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor reserves the right to disqualify any person or address suspected of submitting fraudulent entries or of tampering with the entry process. All entries become the property of the Sponsor and will not be returned.

**Agreement to Official Rules:** Entry and participation in this Contest constitutes participant’s full and unconditional agreement to abide by these Official Rules (exact compliance is essential) and accept the decisions of Sponsor and its agents as final and binding in all matters related to this Contest. **Drawing and Notification:** At the end of the Contest Period, Sponsor will select in a random drawing amongst all valid entries received during the Contest Period:

An entry will be deemed to be received on the date an entrant comments under the contest post with the link to his video. The odds of winning will depend on the total number of successful entries received. Winners will be announced on the Facebook page of Despicable Me: Minion Rush and notified by telephone, private message on Facebook, email and/or mail. If there are an insufficient number of entries, Sponsor reserves the right not to award all the prizes. Judges' decisions in all matters relating to this Contest are final.

**Prizes:**

- Three (3) Grand Prize Winners will receive Six Thousand Tokens (6,000) each, to be used in Despicable Me: Minion Rush (Approximate Retail Value of fifty US dollars (\$50)).
- Two (2) Consolation Prize Winners will receive Two Thousand Tokens (2,000) each, to be used in Despicable Me: Minion Rush (Approximate Retail Value of twenty US dollars (\$20)).

Tokens refer to one of the virtual currencies of Despicable Me: Minion Rush.

**Prize Conditions:** Winners are solely responsible for all applicable federal, state, and local taxes associated with the receipt of any prize. **The prize winner address cannot be a P.O.
