

## **“Dragon Love!” Instagram Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Dragon Love! Instagram Sweepstakes" ("Sweepstakes") will begin at 08:30 a.m. PST on February 15, 2016 and end at 08:30 a.m. PST on February 18, 2016 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

If you do not have an account on Instagram, you must create one by following instructions on Instagram.com. Creating an account is free. Once logged in, go to <https://instagram.com/dragonmanialelegends/> and follow the @dragonmanialelegends account. To enter the Sweepstakes you have to post an in-game screenshot on your Instagram account of your most beloved dragon from the Dragon Mania Legends game and add the #DMLlove hashtag in the description of your post (the "Submission"). Submit your in-game screenshot of your most beloved dragon with the said hashtag to receive one entry into the Sweepstakes.
