

## **“Order & Chaos Photogroup” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Order & Chaos Photogroup" ("Sweepstakes") will begin at 12:01 a.m. GMT on September, 5 and end at 11:59 p.m. GMT on September, 11, 2014 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

The Sweepstakes Approximate Retail Value ("ARV") is \$447.75.
