

“Guess the class” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Guess the class Sweepstakes" ("Sweepstakes") will begin at 16:00 p.m. GMT on November, 21 and end at 23:59 a.m. GMT on November, 28 2016 ("Sweepstakes Period").
