

“Guess who's on the picture” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's “Guess who's on the picture Sweepstakes” (“Sweepstakes”) will begin at 2:00 p.m. GMT on November, 24 and end at 2:00 p.m. GMT on December, 1, 2015 (“Sweepstakes Period”). Sweepstakes is sponsored by Gameloft Inc. (“Sponsor”).

Eligibility: Sweepstakes is open to individuals (excluding residents of the province of Quebec in Canada, Cuba, Iran, Syria, North Korea, Italy, Brail, Myanmar (formerly Burma) and Sudan and any other jurisdiction where the Contest would be prohibited by law; excluding Hasbro employees) who are at least thirteen (13) years old at the time of entry, who have an existing Internet connection and who did not purchase any products, services or equipment for the purposes of entering this Sweepstakes. To Enter: During the Sweepstake Period, comment on the Sweepstake post on My Little Pony Game's Facebook page at <https://www.facebook.com/MyLittlePonyTheGame>. If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free. Once logged in, go to <https://www.facebook.com/MyLittlePonyTheGame> and comment on the Sweepstakes Post. To enter the Sweepstakes you have to like the post (the “Submission”). Submit your comment with your idea of who's at the picture and leave your friend code to receive one entry into the Sweepstakes.

Each entrant may submit only one entry during the Sweepstakes Period. Any attempt by any person to enter more than one entry by using multiple/different email addresses, identities, registrations, or any other methods will void all entries entered by that person and that person, at the sole discretion of Sponsor, may be disqualified from the Sweepstakes. Use of any automated system or similar devices to participate is prohibited and will result in disqualification.

- 55 gems gems in-game currency for My Little Pony Game will be awarded to 20 people selected using random.org from all eligible participants. This prize will be awarded for sure, no matter how many comments the post receives.

- If the number of post comments goes over 500, we will increase the number of winners to 30

The Drawing of the winners will take place until 2:00 p.m. GMT on December, 10, 2015 and the prizes will be awarded until 02:00 p.m. GMT on December, 20, 2015.

In order to receive the prizes, all participants must be logged-in with Facebook in the game.

An entry will be deemed to be received on the date an entrant posts a comment with the correct answer. The odds of winning will depend on the total number of successful entries received. Winners will be notified by telephone, email and/or mail or directly in-game.

Prizes:

- twenty (20) Grand Prize Winner will receive fifty five (55) gems in-game currency for My Little Pony Game (US\$4,99) Grand Prize Average Retail Value (ARV) is US\$100.

- thirty (30) Grand Prize Winner will receive fifty five (55) gems in-game currency for My Little Pony Game (US\$4,99) Grand Prize Average Retail Value (ARV) is US\$150 if the number of post comments goes over 500.

The value of the prizes awarded randomly is of \$100 for 20 Winners and of \$150 for 30 Winners

The Sweepstakes Approximate Retail Value ("ARV") is \$125.
