

## **“Six Guns” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. “Six Guns Sweepstakes” (“Sweepstakes”) will begin at 6:00 pm Eastern Standard Time (“EST”) on April 4, 2012 and end at 06:00 pm EST on April 11, 2012 (“Sweepstakes Period”).

The odds of winning will depend on the total number of eligible entries received. Winner will be notified by telephone, email and/or mail. Upon initial notification and verification of potential Grand Prize winner, confirmation will be sent to the winner in writing via e-mail. If there are an insufficient number of entries, Sponsor reserves the right not to award all the prizes. Judges' decisions in all matters relating to this Sweepstakes are final.
