

## **Gameloft HTC EVO 3D Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. "Gameloft HTC EVO 3D Sweepstakes" ("Sweepstakes") will begin at 10:00am Eastern Standard Time ("EST") on September 29, 2011 and end at 09:59pm EST on October 13, 2011 ("Sweepstakes Period"). Once logged in, go to <http://www.facebook.com/gameloftandroid> and <http://facebook.com/HTCUSA> and become a fan of both of these profiles. Once you're a fan of both, you can go on the "Gameloft HTC EVO 3D Sweepstakes" sweepstakes page and enter the Sweepstakes by completing the puzzle within the 2:00 minute time limit. If a user fails to complete the puzzle within the 2:00 minute time limit, he/she may "share" the sweepstakes on his/her Facebook wall for another chance. The odds of winning will depend on the total number of
