

## **“HOC Update” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "HOC Update Sweepstakes" ("Sweepstakes") will begin at 16:00 a.m. GMT+2 on May, 20th and end at 16:00 p.m. GMT+2 on May, 22nd, 2014 ("Sweepstakes Period").
