

“Little Big City 2” Facebook Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free. Once logged in, go to the local Gameloft's Facebook page corresponding to your country of residence following the above links and post on the page.
