

SWEEPSTAKES RULES

Level Up Sweepstakes Nitro HD Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. "Level Up Sweepstakes Nitro HD" ("Sweepstakes") will begin at 10:00am Eastern Standard Time ("EST") on December 21, 2011 and end at 09:59pm EST on January 11, 2012 ("Sweepstakes Period").

Eligibility: Sweepstakes is open to all legal residents of the United States, seventeen (13) years of age or older, as of December 21, 2011, except employees (and immediate family members spouse and children, parents, in-laws and siblings and spouses of the foregoing or anyone living in households of such employees) of Sponsor, its parent, subsidiaries, affiliates and its advertising, sweepstakes or promotion agencies, and any other entity engaged in any way in the development, production, printing, distribution or execution of this Sweepstakes (collectively, the "Sweepstakes Entities"). If it is found that a person who does not meet the eligibility criteria set forth in these rules has submitted an entry, that entry will be deemed ineligible and any prize awarded shall be revoked. How to Enter:

a. Accessing Sweepstakes on Facebook: Become a fan of Gameloft's profile on Facebook.com at <http://www.facebook.com/gameloft> and LG USA Mobile profile at <http://www.facebook.com/LGUSAMobile>. If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free. Once logged in, and a fan of both pages, you can go on the "Level Up Sweepstakes Nitro HD" sweepstakes page and enter the Sweepstakes by entering your name, device and email address. Entrants will be asked to select the game they would like to win between N.O.V.A 2, Dungeon Hunter 2 and Let's Golf 2.

b. Alternative Method of Entry: To enter without using Facebook, hand print your name, complete address (no P.O. Boxes), day and evening phone numbers, email address (if any), on a 3" x 5" piece of paper and send it in a hand-addressed, stamped envelope, to Gameloft, "Level Up Sweepstakes Nitro HD" sweepstakes, 45 W. 25th St., 9th Floor, New York, NY10010. Limit one mail-in entry per person.

Limit: Each entrant may submit no more than one entry during the Sweepstakes Period. Any attempt by any person to enter more than once by using multiple/different email addresses, identities, registrations, or any other methods will void all entries entered by that person and that person, at the sole discretion of Sponsor, may be disqualified from the Sweepstakes. Drawing and Notification: Winners will be selected from all eligible entries received in a random drawing at the end of the Sweepstakes Period on or about January 12, 2012. Ten (10) First Prize winners will be selected to win a LG Nitro HD device. Ninety (90) Second Prize winners will be selected to win one of the three Gameloft games. Winners will be notified on or about January 12, 2012. An entry will be deemed to be received on the date an entrant fills out the online entry form. The odds of winning will depend on the total number of eligible entries received each day. Winners will be notified by email. If there are an insufficient number of entries, Sponsor reserves the right not to award all the prizes. Judges' decisions in all matters relating to this Sweepstakes are final.

Verification of Potential Winners: All potential sweepstakes winners are subject to verification by Sponsor or Administrator, whose decisions are final AND BINDING IN ALL MATTERS RELATED TO THE Sweepstakes. An entrant is not a winner of any prize unless and until entrant's eligibility has been verified and entrant has been notified that verification is complete. Potential winners must continue to comply with all terms and a condition of these Official Rules and winning is contingent upon fulfilling all requirements. The potential Sweepstakes winners will be notified by email. If a potential winner of any prize cannot be contacted within the required time period (if applicable), potential winner forfeits prize. In the event that a potential winner of any prize is disqualified for any reason, the applicable prize will be awarded to an alternate winner by random drawing from among all remaining eligible entries.

Prizes: - Ten (10) First Prize winners will receive one (1) LG Nitro HD device (\$599.99). The First Prize Average Retail Value (ARV) is \$5,999.90.
- Ninety (90) Second Prize winners will receive one (1) Gameloft game (between \$.99 and \$6.99). In the case that a winner does not own a device compatible with the offered Gameloft game, Gameloft will offer such winner another Gameloft Game compatible with the winner device. The Second Prize Average Retail Value (ARV) is between \$59.40 and \$419.40 depending on the games.
