

## **“My Little Pony YouTube Giveaway” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "My Little Pony YouTube Giveaway" ("Sweepstakes") will begin at 01:00 p.m. GMT on April 27, 2017 and end at 01:00 p.m. GMT on May 4, 2017 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

**Eligibility:** Sweepstakes is open to individuals (excluding residents of the province of Quebec in Canada, Cuba, Iran, Syria, North Korea, Italy, Brail, Myanmar (formerly Burma) and Sudan and any other jurisdiction where the Sweepstakes would be prohibited by law) who are at least thirteen (13) years old or who are over the legal age of majority in the country of residence where required by law at the time of entry, who have an existing Internet connection and who did not purchase any products, services or equipment for the purposes of entering this Sweepstakes. Once logged in, go to <https://www.youtube.com/channel/UCE2DwkFw92RA6PNcZxv5D1A>, become a Subscriber of the My Little Pony Game channel on YouTube, like and comment on the Sweepstakes Post. To enter the Sweepstakes, subscribe to the Channel, like the Sweepstakes Post and answer to the following question "Who's your favourite character of the Episode "To Where and Back Again" in the comment section of the post (the "Submission"). Submit your comment, like the Post and Subscribe the Channel to receive one entry into the Sweepstakes. Make sure that you have confirmed your YouTube name in your account settings, otherwise your Submission will not be a valid entry.

By uploading your Submission, you represent and warrant that your Submission conforms to the Submission Guidelines and Content Restrictions (collectively, the "Submission Requirements") set forth below and that Sponsor, in its sole discretion, may remove your Submission and disqualify you from the Sweepstakes if it believes, in its sole discretion, that your Submission fails to conform to the Submission Requirements. *For all Submissions:* The person who is the authorized account holder of the Account that is used to post a Submission will be deemed to be the entrant. Then, Three (3) First Prize Winners will be selected from all the remaining valid entries (excluding the One (1) Grand Prize Winners already selected above) received during the Sweepstakes Period, in a random drawing on or about May 5, 2017.

Entrants cannot win multiple prizes.

An entry will be deemed to be received on the date an entrant fills out the online entry form. The odds of winning will depend on the total number of successful entries received. Winners will be notified by private message. Upon initial notification and verification of potential winners, confirmation will be sent to the winners in writing private message. If there are an insufficient number of entries, Sponsor reserves the right not to award all the prizes. Judges' decisions in all matters relating to this Sweepstakes are final.

- One (1) Grand Prize Winners will receive One Thousand (1000) gems (in-game currency) to be used in My Little Pony Game. The Prize Average Retail Value is Seventy US Dollars (US\$70).

- Three (3) First Prize Winners will each receive One Hundred Twenty (120) gems (in-game currency) to be used in My Little Pony Game. The Prize Average Retail Value is Ten US Dollars (US\$10).

The Sweepstakes Approximate Retail Value ("ARV") is One Hundred US Dollars (\$100).

**Prize Conditions:** Winners are solely responsible for all applicable federal, state, and local taxes associated with the receipt of any prize. **The prize winner address cannot be a P.O.
