

## **“MOE Spy Giveaway” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "MOE Spy Giveaway" ("Sweepstakes") will begin at 08:00 p.m. UTC+3 on May 30, 2016 and end at 08:00 p.m. UTC+3 on June 3, 2016 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

**Eligibility:** Sweepstakes is open to players that have an active March of Empires' account (March of Empire is a game free to download and creating an account is free) (excluding residents of the province of Quebec in Canada, Cuba, Iran, Syria, North Korea, Italy, Brail, Myanmar (formerly Burma) and Sudan and any other jurisdiction where the Contest would be prohibited by law) who are at least thirteen (13) years old at the time of entry, who have an existing Internet connection and who did not purchase any products, services or equipment for the purposes of entering this Sweepstakes. If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free. Once logged in, go to <https://www.facebook.com/MarchOfEmpires/> and comment on the Sweepstakes Post. On the Sweepstakes Post, you will be presented with visuals of three (3) different spies' characters. Each spy character has a designated number which is either 1, 2 or 3. You will have to guess which one of the three (3) spies is the Assassin. To enter the Sweepstakes, write the number you have chosen (1, 2 or 3) to state which spy character you think is the Assassin in the comment section of the Sweepstakes post and state your platform (iOS, Android or Windows), in-game name, Realm ID and Castle level (the "Submission"). Submit your comment to receive one entry into the Sweepstakes
