

“MOE Vikings Giveaway” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "MOE Vikings Giveaway" ("Sweepstakes") will begin at 08:00 p.m. UTC+2 on December 26, 2016 and end at 08:00 p.m. UTC+2 on January 6, 2017 ("Sweepstakes Period"). To enter the Sweepstakes, write in the comment section the number of presents you see in the video which will be on the Sweepstakes post and also state your platform (iOS, Android or Windows), in-game name, Realm ID, and User Id (found in the "About" section of the game) (the "Submission").
