

## **“March of Empires - Halloween” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Once logged in, go to <https://instagram.com/marchofempires/> and follow the @marchofempires account. To enter the Sweepstakes, you have to like the sweepstake image to enter. Leave your game info (in-game name, Realm ID, player level, castle level and platform) as well as the hashtags #MarchofEmpires and #Giveaway in the comment section. (the "Submission").
