

## **“Me and My Dragon!” Instagram Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Me and My Dragon! Instagram Sweepstakes" ("Sweepstakes") will begin at 08:30 a.m. PST on April 29, 2016 and end at 08:30 a.m. PST on May 3, 2016 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. If you do not have an account on Instagram, you must create one by following instructions on Instagram.com. Creating an account is free. Once logged in, go to <https://instagram.com/dragonmanialelegends/> and follow the @dragonmanialelegends account. To enter the Sweepstakes you have to post a picture on your Instagram account of yourself playing Dragon Mania Legends or holding a Dragon Mania Legends fan-art (drawing, sculpture, plush, etc.) and add the #MeandMyDragon hashtag in the description of your post (the "Submission"). - Four (4) Winners will each receive nine hundred (900) Gems (in-game currency) to be used in the game Dragon Mania Legends. The Prize Average Retail Value (ARV) is Twenty Five US Dollars (US\$25).

The Sweepstakes Approximate Retail Value (“ARV”) is One Hundred US Dollars (\$50).

**Prize Conditions:** Winners are solely responsible for all applicable federal, state, and local taxes associated with the receipt of any prize. **The prize winner address cannot be a P.O.
