

## **“Oregon Trail: American Settler Cash Giveaway” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Oregon Trail: American Settler Cash Giveaway" ("Sweepstakes") will begin at 9:00 a.m. EST on May, 8 and end at 9:00 a.m. EST on May, 11, 2014 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

Once you're a fan, you can go on the Sweepstakes page on Oregon Trail: American Settler's Facebook page. To enter the Sweepstakes, answer the question by commenting. Click the submit button to receive one entry into the Sweepstakes.

Each entrant may submit only one entry during the Sweepstakes Period. Any attempt by any person to enter more than one entry by using multiple/different email addresses, identities, registrations, or any other methods will void all entries entered by that person and that person, at the sole discretion of Sponsor, may be disqualified from the Sweepstakes. - One (1) Grand Prize Winner will receive 50 in-game cash (US\$9.99). Grand Prize Average Retail Value (ARV) is US\$9.99.

- Nine (9) Runner-up Winners will receive 20 in-game cash (US\$4.99). Runner-up Average Retail Value (ARV) is US\$4.99.

The Sweepstakes Approximate Retail Value ("ARV") is \$55.00.

**Prize Conditions:** Winners are solely responsible for all applicable federal, state, and local taxes associated with the receipt of any prize. **The prize winner address cannot be a P.O.
