

## **“Oregon Trail: American Settler Cash Giveaway” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Oregon Trail: American Settler Cash Giveaway" ("Sweepstakes") will begin at 9:00 a.m. EST on July, 4 and end at 9:00 a.m. EST on July, 11, 2014 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

Once you're a fan, you can go on the Sweepstakes page on Oregon Trail: American Settler's Facebook page. To enter the Sweepstakes, answer the question by commenting. Click the submit button to receive one entry into the Sweepstakes.
