"Order and Chaos Online Haradon Community Contest" Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN.

INTERNET ACCESS, VALID E-MAIL AND TWITCH ACCOUNT IS REQUIRED TO PARTICIPATE.

VOID WHERE PROHIBITED BY LAW. ALL FEDERAL, STATE, PROVINCIAL AND LOCAL LAWS AND REGULATIONS APPLY.

1. Eligibility: The "Order and Chaos Online Haradon Community" Contest (the "Contest") is open only to individuals (excluding residents of the Province of Quebec in Canada, Cuba, Iran, Syria, North Korea, Brazil, Italy, Myanmar (formerly Burma), Sudan and any other jurisdiction where the Contest would be prohibited by law) who are at least seventeen (17) years old at the time of entry, who have an existing Internet connection and who did not purchase any products, services or equipment for the purposes of entering this Contest. Employees of Sponsor and any of their parents and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members (any person living in the same household of any of the foregoing for at least four (4) of the twelve (12) months preceding the start of the Contest) of each such employee are not eligible. 3. 5. Contest Submission:

a) Submission Phase: To enter the Contest, participants must have a valid account on Twitch (<u>www.twitch.tv</u>) and broadcast their gameplay of Order and Chaos Online on their Twitch channel during the contest submission period (the "Submission"). If you do not have an account on Twitch, you shall create one by following the instructions on Twitch website. Creating an account is free. By uploading your Submission, you represent and warrant that your Submission conforms to the Submission Guidelines and Content Restrictions (collectively, the "Submission

Requirements") set forth below and that Sponsor, in its sole discretion, may remove your Submission and disqualify you from the Contest if it believes, in its sole discretion, that your Submission fails to conform to the Submission Requirements described herein. Entries submitted will not be returned.

Submission Requirements:

Submission Guidelines:

• The Submission must be your original creation and not subject to any third party interests (other than Sponsor's);

• The Submission cannot have been previously submitted in a promotion of any kind or exhibited or displayed publicly through any means;

• We can only judge entries as submitted to us by the players - please make sure your Twitch account allows for video archiving; and

Content Restrictions:

• The Submission must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, or that constitutes copyright infringement;

• The Submission must not contain brand names or trademarks other than Sponsor mark, which entrant has a limited license to use in the Submission for the sole purpose of creating and uploading a Submission in this Contest;

• The Submission must not contain material that is harmful, abusive, vulgar, sexually explicit, inappropriate, indecent, obscene hateful, tortuous, defamatory, slanderous or libellous or, in a reasonable person's view, otherwise offensive or objectionable;

• The Submission must not contain material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age; and

• The Submission must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where the Submission is created.

- The duration of the Submission Content must be more than 30 minutes.
- Based on the content submissions will be divided into two categories; which are "Help Category" and "Hunt Category"; "Help Category" refers to Player versus Environment Submission Content, and "Hunt Category" refers to Player versus Player zone and Player versus Player Battlefield Submission Content.

Limit: Each participant may submit a maximum of one (1) Submission during the Contest Period. Any attempt by any person to enter more than one (1) Submission by using multiple/different email addresses, identities, registrations, or any other methods will void all Submissions entered by that person and that person, at the sole discretion of Sponsor, may be disqualified from the Contest. Use of any automated system or similar devices to participate is prohibited and will result in disqualification.

For all Submissions: The person who is the authorized account holder of the Account that is used to post a Submission will be deemed to be the entrant. Entrant is solely responsible for obtaining any and all permissions and clearances to the text, art work, audio effects, names, themes, ideas, and all other materials, created, developed or used by entrant in a Submission. If requested by Sponsor, entrant must be able to provide such permissions and clearance in a form acceptable to Sponsor. In the event there is a conflict between the Twitch Terms and Conditions and these Official Rules with regard to this Contest, these Official Rules shall prevail. Posting a

Submission constitutes entrant's consent to give Sponsor a royalty-free, irrevocable, perpetual, non-exclusive license to use, reproduce, modify, publish, adapt, broadcast, license, create derivative works from the Submission, post, sell, translate, distribute and perform and display such Submissions in whole or in part, on a worldwide basis, and to incorporate it into other works, in any form, media or technology now known or later developed, including for commercial, promotional, marketing or any other purposes. Entrant gives up and releases any claim that any use by Sponsor or its designees of any Submission violates any of entrant's rights, including but not limited to moral rights, privacy rights, rights to publicity, proprietary or other rights, or rights to credit for the material or ideas set forth therein. If necessary, entrant will sign any necessary documentation that may be required for Sponsor or its designees to make use of the non-exclusive rights entrant is granting to use the Submission. Released Parties (as defined in Section 8, below) are not responsible for any hardware or software malfunctions, or any lost, late, stolen, intercepted, damaged, incomplete, invalid, un-intelligible, garbled, delayed or misdirected Submissions; all of the entries for which will be void. Proof of submission of a Submission to the Contest is not proof of delivery or receipt of an entry by Sponsor.

In the event of a dispute as to any Submission, the authorized account holder of the email address used to create the applicable Account used to upload such Submission will be deemed to be entrant and must comply with these Official Rules. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winners may be required to show proof of being the authorized account holder.

b) Voting Phase: At the end of the Submission Phase, the Submissions will be judged by a group of people coming from the marketing and production teams at Gameloft, to determine the winners of Special Prize (the "Special Prize Winner"). The judging process involves collection of information based on, among others, a combination of total views, number of time watched, and consistency to the contest categories; the winners of Grand Prize (the Grand Prize Winner") will be randomly picked among the qualified submissions by a group of people coming from the marketing and production teams at Gameloft.

If a Winner cannot be contacted within a reasonable time period,

The Winner (or his/her parent's or legal guardian's, if such Winner is a Minor) gives up and releases any claim that any use by Sponsor or its designees of the Winner's Submission violates any of such Winner's rights, including but not limited to moral rights, privacy rights, rights to publicity, proprietary or other rights, or rights to credit for the material or ideas set forth therein. Each Winner accepts and acknowledges that Sponsor shall not be obligated to use the Submission and that Sponsor in its sole discretion shall have the right to refrain from using the Submission. Sponsor shall not incur any liability whatsoever arising out of Sponsor's choice to exercise or refrain from any exploitation of its rights hereunder. Each Winner will defend, indemnify and hold harmless Sponsor, Released Parties (as defined in Section 8, below) and any licensee of Sponsor against all claims, damages, liabilities, and expenses (including reasonable counsel fees and legal expenses) arising out of any breach of these Official Rules.

ADVERTISING/PROMOTION AGENCIES, AND PRIZE SUPPLIERS, AND EACH OF THEIR RESPECTIVE PARENT COMPANIES AND EACH SUCH COMPANY'S OFFICERS. DIRECTORS, EMPLOYEES AND AGENTS (COLLECTIVELY, THE "RELEASED PARTIES") WILL HAVE NO LIABILITY WHATSOEVER FOR, AND SHALL BE HELD HARMLESS BY ENTRANT AGAINST, ANY LIABILITY FOR ANY INJURIES, LOSSES, DAMAGES, CLAIMS OR ACTIONS OF ANY KIND, INCLUDING WITHOUT LIMITATION DEATH, PROPERTY DAMAGE, AND CLAIMS BASED ON PUBLICITY RIGHTS. DEFAMATION OR INVASION OF PRIVACY RESULTING IN WHOLE OR IN PART, DIRECTLY OR INDIRECTLY, FROM RECEIPT, ACCEPTANCE, POSSESSION, MISUSE OR USE OF THE PRIZE OR PARTICIPATION IN THIS CONTEST OR PARTICIPATION IN ANY CONTEST-RELATED ACTIVITY.

If terminated Sponsor may, in its sole discretion, determine the winners from among all non-suspect, eligible Submissions received up to time of such action using the judging procedure outlined above. Sponsor reserves the right, in its sole discretion, to disqualify persons whose eligibility is in question or who cannot or do not comply with these Official Rules, or for any other reason whatsoever. Sponsor, in its sole discretion, reserves the right to disqualify any individual it finds to be tampering with the submission process or the operation of the Contest or to be acting in violation of these Official Rules or those of any other promotion or in an unsportsmanlike or disruptive manner and void all associated Submissions. thereto (other than those elements, if any, provided to entrant by Sponsor) are wholly owned original works of authorship developed or created by entrant; (v) the Submission does not and will not infringe upon the copyrights, trademarks, trade names or other proprietary rights of any thirty party; (vi) participant shall comply with all applicable laws and regulations and shall ensure that entrant's Submission is in compliance thereto; (vii) the Submission and entrant's participation in this Contest are not in violation of any agreement or restrictions binding upon entrant; and (vii) participant's Submission shall conform to the Submission Requirements.
