## **Official Rules**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. **To Enter:** Entrants shall have downloaded or download the "Order & Chaos Online" video game application of Gameloft available on iOs or Android (the "Application"). The application is free for download. If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free. Once logged in to your Facebook account (the "Account"), visit Order & Chaos Online's Facebook page at <a href="https://www.facebook.com/O.n.C.Online">https://www.facebook.com/O.n.C.Online</a>, and go on the Sweepstakes post on Order & Chaos Online's page. To enter the Sweepstakes, you shall post a screenshot containing the game character. In order for an entry to be valid the screenshot must contain both the character and the character's current game level, and details identifying the same character (The character's name, server location, and platform (Android, iOS or Windows) also included in accompanying post text.
