

“Rival Knights Christmas Gems Giveaway” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Dungeon Hunter Update Gems Giveaway" ("Sweepstakes") will begin at 09:00AM EST on December 22nd and end at 09:00AM EST. on December 25th, 2014 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").
