

## **“Race to Dungeon 40” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Race to Dungeon 40 Sweepstakes" ("Sweepstakes") will begin at 12:01 a.m. GMT on June, 25 and end at 11:59 p.m. GMT on June, 29, 2014 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

**Eligibility:** Sweepstakes is open to individuals (excluding residents of the province of Quebec in Canada, Cuba, Iran, Syria, North Korea, Brazil, Italy, Myanmar (formerly Burma) and Sudan and any other jurisdiction where the Contest would be prohibited by law) who are at least eighteen (18) years old at the time of entry, who have an existing Internet connection and who did not purchase any products, services or equipment for the purposes of entering this Sweepstakes. - Twenty (20) First Prize Winners will receive 10,000 coins, in-game currency for Dungeon Gems (US\$4). Prize has an Average Retail Value (ARV) of US\$4.

The Sweepstakes Approximate Retail Value ("ARV") is \$80.

**Prize Conditions:** Winners are solely responsible for all applicable federal, state, and local taxes associated with the receipt of any prize. **The prize winner address cannot be a P.O.
