

## **“Scrat's Pumpkins” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Scrat's Pumpkins Sweepstakes" ("Sweepstakes") will begin at 08:00 p.m. GMT on October, 30 and end at 08:00 p.m. GMT on October, 31st, 2013 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

**Eligibility:** Sweepstakes is open to individuals (excluding residents of the province of Quebec in Canada, Cuba, Iran, Syria, North Korea, Brazil, Italy, Myanmar (formerly Burma) and Sudan and any other jurisdiction where the Contest would be prohibited by law) who are at least eighteen (18) years old at the time of entry, who have an existing Internet connection and who did not purchase any products, services or equipment for the purposes of entering this Sweepstakes. - One (1) Grand Prize Winner will receive 300 Acorns, in-game currency in Ice Age Village (US\$17). Grand Prize Average Retail Value (ARV) is US\$17.

The Sweepstakes Approximate Retail Value ("ARV") is \$17.
