

“Siegefall Monthly Facebook Giveaway” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Siegefall Monthly Facebook Giveaway" ("Sweepstakes") will begin at 10:00 a.m. EST on October, 3 and end at 9:00 a.m. EST on October 9th, 2015 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

To enter the Sweepstakes, answer the posted question by commenting. Each entrant may submit only one entry during the Sweepstakes Period.
