

“Siegefall Update 6” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER; FEW WILL WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. Gameloft's "Siegefall Update 6 Sweepstakes" ("Sweepstakes") will begin at 09:00 a.m. GMT on April 30th and end at 09:00 a.m. GMT on May 6th, 2016 ("Sweepstakes Period"). Sweepstakes is sponsored by Gameloft Inc. ("Sponsor").

If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free. Once logged in, go to <https://www.facebook.com/Siegefall> and comment on the Sweepstakes Post to enter the Sweepstakes (the "Submission"). Submit your comment to receive one entry into the Sweepstakes.

Each entrant may submit only one entry during the Sweepstakes Period.
