## SWEEPSTAKES RULES

#### Sprint Unlimited Gaming Sweepstakes Official Rules

## How to Enter:

**a.** Accessing Sweepstakes on Facebook: Become a fan of Gameloft's profile on Facebook.com at <a href="http://www.facebook.com/gameloft">http://www.facebook.com/gameloft</a> and Sprint's profile at <a href="http://www.facebook.com/sprint">http://www.facebook.com/sprint</a>. If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free. Once logged in, and a fan of both pages, you can go on the "Sprint Unlimited Gaming Sweepstakes" sweepstakes page and enter the Sweepstakes by entering your name, device and phone number. You may "share" the Sweepstakes on your Facebook wall to get additional entries to the Sweepstakes each day. Limit five entries per day.

Ten (10) winners will be selected each day during the Sweepstakes Period from all entries that successfully complete entry. Winners will be notified within 4-5 days after their entry. An entry will be deemed to be received on the date an entrant fills out the online entry form. The odds of winning will depend on the total number of eligible entries received each day. Winners will be notified by email. If

there are an insufficient number of entries, Sponsor reserves the right not to award all the prizes. Judges' decisions in all matters relating to this Sweepstakes are final.

**Verification of Potential Winners:** All potential sweepstakes winners are subject to verification by Sponsor or Administrator, whose decisions are final AND BINDING IN ALL MATTERS RELATED TO THE Sweepstakes. An entrant is not a winner of any prize unless and until entrant's eligibility has been verified and entrant has been notified that verification is complete. Potential winners must continue to comply with all terms and a condition of these Official Rules and winning is contingent upon fulfilling all requirements. The potential Sweepstakes winners will be notified by phone, registered mail and/or text message. If a potential winner of any prize cannot be contacted within the required time period (if applicable), potential winner forfeits prize. In the event that a potential winner of any prize is disqualified for any reason, the applicable prize will be awarded to an alternate winner by random drawing from among all remaining eligible entries.

**Prizes**: Three Hundred and Fifty (350) winners will receive one (1) Gameloft game. In the case that a winner does not own a device compatible with the offered Gameloft game, Gameloft will offer such winner another Gameloft Game compatible with the winner device. The Prize Average Retail Value (ARV) is between \$.99 and \$6.99 depending on the game.
