

**GAMELOFT'S "#MyDisneyKingdom" TWITTER SWEEPSTAKES**  
**Official Rules**

Sweepstakes is sponsored by Gameloft Inc. ("Sponsor"). Sweepstakes is not sponsored, endorsed, administered by, or associated with Twitter.
